Enclosed is your 2018 information sheet. Please make any necessary corrections and return it along with your 2018 dues payment to the Association Office in the supplied envelope. Reminder – You can pay your 2018 dues & fees with Visa/Mastercard/Discover (3.25% surcharge on credit cards). Even if there are no corrections, your information sheet <u>MUST</u> be returned to the Association Office before your 2018 decals can be issued.

Please note the following when reviewing your 2018 information sheet:

- 1. Do not discard your photo ID amenity cards. Replacement ID card fee is \$20.00. Members in good standing, along with their children residing at the same principal residence, are entitled to amenity cards. Photos must be on file to receive Amenity card. All children's ID cards dated prior to 01/2014 have been deactivated. If your child(ren) has not received a new card in 2015 or 2016, current photos must be submitted. You may still have a photo taken at the office; however, those cards will be processed as time and resources allow.
- 2. Only personal property (vehicles, ATV's, watercraft, campers, golf carts, etc) owned by Members in good standing are entitled to be registered at Lake Carroll.
- 3. Lake Carroll decals are issued only when:
  - a. Amenity cards have been issued and
  - b. Dues, assessments, fees and required information are CURRENT.
- 4. Licensed Vehicle Decals are issued only for vehicles owned by members in good standing. Mandatory information required: Make/Model/Year, License Plate #'s & copy of your state registration card must be on file BEFORE vehicle decals will be issued.
- 5. You are required to supply the Association with information regarding current insurance coverage for WATERCRAFT, OFF-ROAD TRAIL VEHICLES, SNOWMOBILES, AND GOLF CARTS. <u>PLEASE NOTE:</u> The minimum liability insurance coverage is \$500,000. All ATV & Snowmobile insurance policies must also have Lake Carroll Association added as an "additional insured". Check your policies to see if changes are needed to meet these requirements.
  - a. You are required to supply the Association with your **CURRENT STATE REGISTRATION** for all WATERCRAFT AND SNOWMOBILES.
  - b. **ATV Decals** will be issued upon payment of decal, receipt of ownership each year. Acceptable forms of ownership shall be State registration, title or insurance. Proof must be in member's name.
  - c. Camper Decals will be issued upon payment of decal & seasonal site or storage fees & proof of ownership.
  - d. Golf Cart Decals will be issued upon payment of decal & trail or storage fees.
  - e. **Snowmobile Decals** will be issued upon payment of decal, trail fees & proof of membership in an alliance snowmobile club.
  - f. Watercraft Decals will NOT be issued until at least one member per lot has taken a Boater Safety Course. Owners who have not previously taken the IDNR test must complete both the IDNR Boat Safety Course and the LCA Boat Safety Quiz. If you need to attend a Boat Safety Course, contact the Association Office for dates of future classes or for a number to contact the IDNR.
- 6. One licensed vehicle decal will be issued per year at no charge. Each additional decal is **\$30.00**. This includes additional licensed vehicles, campers, golf carts, off-road trail vehicles, snowmobiles, and watercraft.
- 7. LAKE CARROLL HOMEOWNERS: Lake Phone number should be your (493) number or the cell phone number you use as your primary number at your Lake residence. This information will be used for the 2018 Lake Carroll Homeowner Phone Directory. If you choose to be excluded from the Directory, you must return the exclusion form included in this mailing by January 31, 2018.

#### PAYMENT OPTIONS:

## CASH, CHECK or CREDIT CARD (VISA, MASTERCARD, DISCOVER; 3.25% surcharge on all credit card purchases)

In full - Payment of \$1,608.00 due by January 31, 2018

#### <u>OR</u>

<u>Quarterly</u> - Installments of \$402.00 plus a handling fee of \$25.00 per quarter, for a total of \$427.00/quarter, which are due and payable by the last day of the month for each quarter (January-April-July-October). The quarterly payment process is considered an extended privilege to the membership and may be revoked by the General Manager for such reason as, but not limited to: abuse of late payments, bad checks or bad credit/debit cards.

### LATE FEE/LIENS

A late fee of **\$100.00 per dues paying lot** will be added to each account if payment is not postmarked by January 31, 2018. Late fees of \$100.00 per dues-paying lot will be added for all other quarters when payments are not postmarked by the due dates.

If a payment has not been received by March 1, 2018, a lien letter (\$250.00 fee) will be mailed. A lien (\$500.00 fee per dues-paying lot) will be placed against the property if no payment is received by March 31, 2018.

Lake Carroll is a 5,000 acre complex established in 1972 The Dam/Lake was constructed during 1973/74
